

# President's Report to State Council – Term 3

Colleagues, welcome to Term 3 State Council. Thank you for stepping out of your schools to carry forward the voices of your colleagues in your local PPC. Your focus and input are incredibly important in strengthening our Association and ensuring clarity and consistency across the state. Our priority will be the business of the Association and important updates. Thank you also to our chairs and observers for their work since the last Council in carrying forward our positions.

Congratulations to colleagues across the state for the amazing work being done in schools. I am so proud of the commitment to public education. Public Education Week, Book Week, Father's Day stalls, and Arts Festivals are just some of the events that have lit up our schools this term.



Thank you to the PPCs who have been attending their local Federation meetings to raise issues. Feedback suggests most have been warmly welcomed, with opportunities to speak about concerns and gain support through those meetings.

We are fortunate to have Murat spending an hour with us on Thursday to provide critical updates and answer questions. We were also scheduled to have our Acting Minister join him, but unfortunately, she has had to withdraw.

We will also hear from school support teams representing Health & Safety, School Promotions, Primary Curriculum, Fraud & Corruption, and School Excellence. They will provide updates and answer questions on new resources, policies, and procedures to support colleagues.

Members of the State Executive recently met with the Acting Minister, the Hon. Courtney Houssos MLC. We raised key issues, including principal and workforce safety—particularly the Community Charter and the need for it to remain explicit in calling out unacceptable behaviour and outlining consequences. Minister Houssos also updated us on proposed legislation to support the code of conduct. As this legislation is currently cabinet-in-confidence, we cannot provide detail here, though Murat may be able to share more.

We also spoke with the Minister about the importance of the APC&I role and proposed broadening it into a Teaching and Learning role covering HPGE, explicit teaching, and support for all learners. This discussion extended to Assistant Principal and teaching principal release more broadly, highlighting its importance in supporting the implementation of the NSW Public Education Plan.

Our final topic was the resourcing of public school preschools, particularly the provision of an executive allocation and administrative support. While this request was not funded in this year's budget, it remains under consideration. The allocation will not be a five-day entitlement but will be proportional to the number of preschool students.



I also had the opportunity to meet with Henry Rajendra, President of the NSW Teachers Federation, and Deputy President Amber Flohm. With Henry, I raised issues including support class placement, release for Assistant Principals and small school principals, APC&I, and support for students with complex needs. Henry noted that Assistant Principal and small school release are part of the Federation's upcoming campaign for increased staffing entitlements and asked for our support by encouraging teachers and principals to complete the Federation survey.

With Amber, I raised the issue of principals being unable to access extended leave to support a transition to part-time work in the last five years of their career. Amber explained this was a government-wide policy but agreed to take it forward for further discussion. We also explored sick leave entitlements and the possibility of converting unused leave into a retirement benefit to reduce

workforce absenteeism in the later years of service. Preschool staffing, complexity funding, and release time were also discussed.

I have also been in discussions with Tim Bullard, CEO of AITSL, reflecting on the Teacher Standards, Middle Leader Standard, and Principal Standard. With the teacher and principal standards now well established, and the introduction of the Middle Leader Standard, we discussed whether it may be time to review the continuum. We also explored the idea of a Deputy Principal Standard. I raised concerns about UTS suspending their ITE courses. While AITSL has no authority over this, Tim felt there is enough capacity across other providers to maintain training levels.

Finally, Professor Donna Cross is leading work on the system and school response to bullying. She shared a range of data, two findings in particular standing out:

- Students identified as disruptive in class reported higher levels of being bullied.
- Primary schools recorded higher levels of face-to-face bullying, likely reflecting reduced access to online devices compared to high schools.

Professor Cross will provide a report to government later this year, which will inform future action. It was heartening to hear her deep understanding of the challenges schools face and the importance of bringing parents along on the journey to improve outcomes.

#### **Stewart House Pyjama Day**

Thank you to all of the wonderful schools who participated in Stewart House's Pyjama Day fundraiser. It was a successful day for our charity partner.

Remember, it is not too late to support Stewart House this year.

#### **Voluntary Contributions**

Wanita, Chair of the Finance and Administration Reference Group, and I have been involved in discussions around voluntary contributions. The Department is looking for ways to avoid the annual headlines about schools asking for large school "fees." The Federation, P&C, SPC, and other groups are also part of these discussions.

We have argued that schools should be able to seek funding from their local communities where appropriate. We are often told that the current equity funding model directs more funding to high FOEI schools because low FOEI schools are able to generate funds from their communities. If that ability is removed, then the funding model as a whole needs to be reconsidered.

We have also asked for much clearer communication about what is considered a voluntary contribution. For example, does this include book packs, excursions, and extra-curricular activities?

#### **Anxiety Project - Student Wellbeing Seminar**

Recently, our Anxiety Project Team partnered with The ParentShop to deliver a student wellbeing seminar. The keynote speaker was Professor Patrick McGorry, who presented the latest research on anxiety prevalence and key interventions. Some schools involved in the Anxiety Project also shared their experiences and the positive impact the project has had on students.

#### **Annual Conference**

We are looking forward to welcoming around 600 delegates to our Annual Conference in October. The conference will feature a range of international and local speakers to build leadership capacity, drive motivation, and improve wellbeing and resilience. It will be a key part of walking forward together to strengthen public education in NSW. Strong, passionate leaders make strategic and intentional decisions to maximise resources in their schools for the benefit of students.

Those decisions include ensuring their own development, as outlined in the NSW Education Principal Role Statement:

"Are committed to their own professional development and wellbeing in order to enhance their resilience and manage the complexity of the role."

Principals ensure that the Annual Conference is included as a vital part of their professional learning in their Professional Development Plan. They also ensure that the conference is included in their school budget, which is signed off by their finance committee. In making decisions about their professional learning budget, principals also ensure that opportunities and funds are distributed equitably so that all staff have access to quality professional learning.

Directors, Educational Leadership (DELs), have the delegated authority to approve principals' professional learning, travel, and accommodation in line with the travel on official business policy and guidelines. A SAP authority to travel application must be completed and approved by the DEL.

Principals must not approve their own professional learning, accommodation, or travel. For example, principals should not have their SAM use a PCard to book accommodation and then sign off on it themselves in Expense 8.

The procedures (section 1.1) include attendance at a conference as a legitimate reason to travel. Section 1.6 outlines what the DEL must assess in their approval process:

- The safety of the staff member and local conditions.
- Whether the conference or seminar involves evening sessions.
- Whether an early start is required at a location away from the staff member's normal workplace.
- Whether the available travel budget is sufficient to cover the estimated cost.

In making a decision, the DEL will also consider the expense limits and examples in the procedures to ensure the daily limit of \$388 is not breached.

In making their case for approval, principals can highlight safety concerns (such as walking around Sydney at night), their wellbeing (ensuring sufficient rest and reduced stress by staying close to the venue), and practical travel considerations.

At this year's conference, there will be evening sessions. On Wednesday evening, our Secretary, Murat Dizdar, will present.

Thank you to the Conference Committee, led by Kylie Donovan, for their work.

#### **APPA Conference**

Last week, nine of our Executive attended the Australian Primary Principals Association (APPA) Conference in Brisbane. In the past, we have funded a contingent from State Council to attend, but due to current interstate travel restrictions, approval was granted only for a smaller number of the Executive team.

The APPA Conference brings together primary principals from all jurisdictions in Australia as well as from New Zealand. It also includes principals from government, Catholic, and independent sectors.

The theme of this year's conference was *Leading Well Together*. Please see the separate APPA report for further detail.

#### **Better, Fairer Schools Funding Agreement (BFSA)**

As you would be aware, the agreement for federal funding has now been signed, and the bilateral agreement with NSW has been published. The timeline in the agreement shows that funding will flow into our system gradually over the next few years, with larger increases from the fifth year onwards.

The key reforms we have committed to in the agreement include:

- Year 1 Phonics Screening (2025)
- Year 1 Numeracy Screening (2026)
- Small Group Tuition (2026)
- Access to health professionals in schools (2025)
- Wellbeing Co-ordinator in every school (2026)
- Attracting and retaining teachers (2025)
- Teacher Professional Learning (2026)

#### Notes:

- Claims and invoices received up to 27<sup>th</sup> August 2025 are reflected in this report.
- Major income items to date for 2025 are the fortnightly membership payments and professional learning income.
- Membership to the NSWPPA is a personal expense and is to be paid by the individual. Principals in relieving positions are encouraged to pay by salary deduction if their relieving tenure is long term on there is an unknown endpoint. Direct deposit is an option for principals in shorter term relieving commitments.
- Our financial year ends on the 31<sup>st</sup> August, we now start the new financial year and the 2024/25 finances will be reported on at the AGM at our upcoming conference.
- Grants to PPCs have been made. The grants are made up of funding for two members to attend the NSWPPA Annual Conference and a location amount.

#### Claims:

- Please book your flights as early as possible and direct through the airline, not through Webjet or similar sites.
- All claims will go to the Treasurer mailbox: <a href="mailto:treasurer@nswppa.org.au">treasurer@nswppa.org.au</a>
- If you are making a claim that has GST reflected on the invoice (ie flights) the sales order that is generated by your SAM needs to include that GST component as well. The school will only see the GST exclusive amount in their overview report.
- Please complete the top part of the claim form to identify your area, reference group, etc.
- Claims will be processed on a Wednesday by Kathy Rudd after I have approved them. She may contact your SAM or yourself to facilitate your claim, ie missing information, receipts, clarify, etc. If your claim hasn't been paid after two Wednesdays from submitting it please contact me.
- We pay for travel costs (airfare, train, motor vehicle, bus, ferry), parking and accommodation (twin share or 50% of single share) when on State PPA business. You will need to organise your own travel. Please do not use a travel agent or online booking service (eg Webjet) as they add additional commission. Booking via the airline website is usually the cheapest option. We will not cover travel insurance.
- Please pay for your own meals, including breakfast and dinner. Morning tea and lunch are usually
  included during PPA business events. There is a reduced rate for full buffet breakfast for all NSWPPA
  members at the Sydney Central.
- When submitting a claim, it is helpful if you can put your claim and evidence together in one file rather than multiple attachments.
- Accommodation for State Council / Reference Group Meetings is organised by Mark Pritchard and is at a twin share rate. Members will pay the additional charge for a single room.

#### **Teacher Relief:**

A relief day is paid when a teaching principal is asked to represent our Association in any capacity. Non-teaching principals may submit a claim for teacher relief if they believe this is an urgent or emergent requirement for the effective running of their school. Each claim will be assessed individually based on its merit; please attach a brief statement outlining the need for your claim. The maximum daily rate paid for a casual teacher is \$700.00. GST is included in the \$700 paid.

#### **Principal Welfare:**

Our association has established a pool of funds available to access support for colleagues when there are no other avenues available. Each application will need to be referred to the NSWPPA State Executive through the Chairperson of the NSWPPA Principal Support Reference Group and can only be accessed through:

- Self-Nomination;
- Nomination from the Area Council President, Regional Support Principal or State Executive; and
- May only be used to support Principals who are financial members of the NSWPPA. Once the type and level of support has been determined and a relief teacher has been employed, the standard NSWPPA claim form is used to claim assistance in the costs incurred. The current rate is \$700.00 per day (including GST and on-costs).

#### **Local PPC Treasurers & Membership:**

Thank you to local area Treasurers and Presidents for their work in following up and promoting membership. I am available to assist treasurers and ensure that they have access to the Treasurer Teams group.

#### **Relieving and Acting Principals**

Relieving and Acting Principals who are in the role for an indefinite period should complete the salary deduction form and submit it to the email address on the bottom of the form. Membership is considered a personal expense (not school) and stays with the individual if they move schools. Please remind any relieving/acting Principals to cancel their salary deductions (by sending a form to EdConnect – please contact Treasurer for the form) once they have completed their relieving role.

# Australian Primary Principals Association (APPA) Report

**The Australian Primary Principals Day** was held on the 1<sup>st</sup>. This day is an initiative of APPA and saw primary principals celebrated across Australia.

#### APPA Conference

APPA held their annual conference in Brisbane this term. In the past the NSWPPA has sent a contingent to the conference but due to current government travel restrictions only a delegation of 9 Principals was able to attend. Still it was a great opportunity for the team to promote the great work being done in public education in NSW, connect and learn from other principals and build their own leadership capacity.

The theme of the conference was "Leading Well Together". Key speakers included Libby Trickett, Ben Sacco, Libbi Gorr, Can McDonald, Gemma Munro, Kirstin Ferguson, Justin Coulson and Gill Hicks.

#### Libby Trickett-Resilience, Teamwork, and Leadership: Lessons from the Pool to the Classroom

Lisbeth 'Libby' Trickett, OAM (née Lenton) is an Australian retired competitive swimmer. She won seven Olympic medals, four of which were gold. Libby was a gold medallist at the 2004, 2008, and the 2012 Summer Olympics. Libby Trickett has given birth to five children. Trickett says "the shape of our family is complete". Famous last words!

Upon retirement from swimming Trickett was involved in efforts to raise awareness about mental health issues. At the conference Libby spoke about resilience, teamwork and leadership from her lessons from the pool to the classroom. During her presentation she promoted her 'Play On' business.

Libby was open and honest with the Principals at the conference. She revealed her parent's separation at 10yo changed her upbringing and her father become estranged for the remainder of her life. Libby attended four schools and experienced anxiety as a child which also followed her to the marshalling area during major swimming meets.

#### Ben Sacco - The Flower Grows from the Ground Up: collectively shaping an education for tomorrow:

Ben's Sacco's keynote highlighted that this year marks the beginning of a new generation, Generation Beta. In 2030 the first Gen Beta children will start their schooling and will be characterised by:

- Al integration
- Hyperconnectivity
- Immersive experiences
- Borderless lifestyles
- Environmentally conscious
- Real world reimagined

Gen Beta will be globally aware, community orientated and collaborative. Collaboration will be the key to learning for Gen Beta. Ben spoke of his notion of Success by design: Process + System – Effort + Consistency and stated that a process and/or system is effective if there is high effort and high consistency and not to focus on the outcomes.

His new book *Disruption in Schools: Understand me before you mark me!* Responding to the daily realities of a school environment looks at what drives behaviour of concerns in educational settings and how we respond to these behaviours and how to create supportive school environments.

#### Dr Cam McDonald- Harnessing Individual Strength to Team Success

Cameron McDonald combines expertise and experience in health and education to inform principals of the future of differentiation and improved outcomes for our students. He believes Generic Health care is a thing of the past and that Precision Health is the new frontier, reshaping how we may gain a deeper understanding of student well-being. He is passionate about translating complex health concepts into actionable strategies, leveraging technology to support meaningful change. Designed with principals and middle leaders in mind, the development of the Learning360 Al Tool offers real-time insights into student performance, personalised learning pathways, and simplified administrative tasks. Having worked closely with schools, Cameron has shaped this tool to be practical, user-friendly, and impactful with promising scope to explore how Al and precision health technologies can build cognitive and emotional profiles to improve behavioural and academic outcomes for students.

#### Gemma Munro -Peaceful Peak Performance

Gemma shared with the conference delegates her unique perspective on transformational change as a leader. With a PhD in performance psychology, Dr Gemma asked us to get clear on what we're here to do, shed the fears, doubts and self-sabotage and lead through change with grace and enthusiasm. The keynote title 'Peaceful Peak Performance' gave participants an understanding of why we keep getting in our own way when it comes to managing ourselves and others through change, sharing easy-to-use tools to navigate change with grace, enthusiasm and skill. Whilst developing a shift in mindset, to start seeing change as an opportunity, not a threat.

# Australian Government Primary Principals Association (AGPPA)

This was the first time the two bodies had met and the aim was to identify opportunities to join our collective voices to strengthen our advocacy. The two bodies worked through a range of issues and topics to identify mutual desired outcomes and possible strategies to advance our advocacy.

The many ideas and challenges were debated, discussed and narrowed down to six priority areas. These were then developed into a joint statement.

#### Joint Statement by ASPA and AGPPA

#### August 2025

On July 21, 2025, Australia's two national peak bodies for public school principals and leaders, the Australian Secondary Principals' Association (ASPA) and the Australian Government Primary Principals' Association (AGPPA), convened for the first time, representing over 11,000 leaders from 7,500 government schools serving 2.8 million students.

United by our commitment to equity and excellence in education, this joint statement reflects our shared objectives towards achieving a world-leading, child-centred education system led by healthy and effective professional educators.

#### 1. Principal Wellbeing & Efficacy

**Objective:** Retain and sustain highly professional principals and school leaders.

#### **Key Outcomes:**

- O Reduced workload and stress, and a sustainable career for principals and school leaders
- Realistic understanding and appropriate classification of the contemporary principals' role
- o Recognition of principals and school leaders as respected educational experts and community leaders

- -Student Wellbeing, Engagement and Safety.

By working together, we believe we can achieve a world-leading education system that is productive, nationally coherent, and child-centred, with educators leading the way. Our joint statement reflects our unified approach to addressing the challenges and opportunities in public education and our determination to advocate for the policies, practices, and resources that will enable every school leader to drive meaningful change in their schools and communities.

### **AGPPA Presidents Meeting**

On Tuesday, 22 July, the AGPPA Presidents held a half-day meeting where AGPPA representation was discussed, an overview of state and association issues occurred (a mini-State of the Nation), and the group strategised how to further advance AGPPA.

The meeting was a success with strong discussion and connection a feature.

### **National Principals Reference Group Meeting with the Federal Education Minister**

As AGPPA President, I was invited to the National Principals Reference Group meeting which was hosted by the Federal Education Minister Jason Clare during the recent school holidays. I was joined at the meeting by APPA President Angela Falkenberg and QASSP Vice President Debbie Hansen, who represented the Australian Primary Principals Association (APPA).

During our meeting, the Minister provided updates on the progress of the Better Fairer Schools Funding Agreement and emphasised the urgent need to tighten child safety legislation. We also discussed the agenda for the upcoming Education Ministers Meeting (EMM) and the Rapid Review aimed at establishing a consistent national standard for addressing bullying in schools. We also explored the process for reviewing and updating the National Teacher Workforce Action Plan, including a focus on school leader wellbeing. The meeting was a valuable opportunity to advocate for our national priorities in education.

## **AGPPA Meeting with Minister Clare**

As President of AGPPA, I met with Federal Minister Jason Clare with Andrew Dalgleish, in his capacity as Vice President of AGPPA. We discussed critical issues affecting government primary schools nationwide.

The conversation highlighted several key topics, including curriculum development, student absences, and inclusion strategies. The meeting addressed concerns about violence in schools and the Federal review into bullying, as well as the review of AERO. We emphasised the need for meaningful engagement with the profession, particularly regarding Principal leadership and the rewriting of ATSIL Principal Standards to include Deputy Principals. Additionally, they underscored the importance of incorporating recommendations from the National Disability Royal Commission and prioritising Principal wellbeing in the upcoming Teacher Workforce Action Plan.

# Australian Primary Principals Day – Friday, 1 August 2025

On Friday 1 August, we celebrated Australian Primary Principals Day, an initiative of the Australian Primary Principals Association (APPA) to publicly recognise and celebrate the leadership and dedication of primary school principals across Australia. The significant impact of primary school leaders to students, staff and their families is invaluable.

Be careful when using P Cards for large purchases. Under \$10000 P Card is appropriate. Other larger purchases on ongoing services- should consider limit order.

The team is here to take the workload off principals, DELs and teachers.

Significantly less workload and streamlined process for teachers and school leaders.

Significant policy changes have removed the blockers – time, workload and isolation.

More support than ever before.

More contexualised and individualized.

Resources and templates are available to support teachers.

Now 2 models and 20 Standard Descriptors instead of 37.

Still have a site visit for a day looking at their practice – evidencing what they are already doing.

No referee reports, now a principal conversation.

No major initiative for lead application, now same process.

One internal observation of a colleague.

Maintenance is now the same as at Proficient. The principal endorses this.

Evidence can be from the last five years.

Feedback given along the way.

Accreditation is now achievable in a short timeframe.

Up to 10 descriptors can now be collaborative evidence. Need to write own narrative (annotations).

EV evidence sets can be used by HALT if have been involved in the initiative.

NESA Recognised Program (NRP) – 6 months or longer. Significant application to NESA.

LECI is also offered as a NRP (halfway to HALT). At Highly Accomplished Level.

No longer dependent on 10-15 years' experience.

HALT is available to preschool teachers, support teachers and aspiring leaders.

Currently there are no preschool teachers at HALT level.

Temps and casual may also be considered.

There is a numeration step.

Teachers will be reimbursed fees once successful.

Please promote the NSW DoE HALT Hub.

A HALT accreditation readiness course TPL0039 is available on MyPL.

Opportunities for expert teachers and leaders to be HALT assessors. NESA provides training.

Last 18 months 83% applicant growth.

Now 264 accredited HALTs in DoE.
